

**Town of New Hope Regular Board Meeting**  
**Wednesday, July 15, 2015 - 7:00 p.m.**  
**Town Hall**

**1. Call to Order.**

Dan Zaborowski called the meeting to order at 7:00 p.m. He opened the meeting leading us in the pledge of allegiance.

**2. Review/Approval of Minutes.**

The minutes of the last monthly meeting were read by Kari Yenter. Todd Knepfel moved to approve the minutes, seconded by Timm Raddatz. Motion carried.

**3. Request for an addition to a cottage on Taylor Road.**

Gerald O'Brien reviewed his proposed plans for an addition to his home on Taylor Road. He stated it will be a 14' addition to extend the current kitchen area. The current 10' deck will be removed to allow for the proposed addition. It was noted that he will not be building closer to the water. Dan Zaborowski informed Mr. O'Brien that the next step is to contact Portage County Planning and Zoning for approval and permits. Timm Raddatz moved to approve the addition to a cottage on Taylor Road and the Clerk will notify Portage County Planning and Zoning of its approval, seconded by Todd Knepfel. Motion carried.

Dan Zaborowski received the signed copy of the agreement between the Town of New Hope and Portage County for the bridge project on River Road. The work will be completed by September 15, 2015.

**5. Road Improvement Report.**

The road projects were discussed. Almost all the road projects are complete with the exception of the bus turn around on North Lake Road. Timm Raddatz said he received a concern about overgrown brush along a section of Sunset Lake Road.

**6. Discussion on Oak Lane.**

The process and possible costs for discontinuing Oak Lane were reviewed. The Board would like to move forward with the process.

**7. Recycling Events.**

Tire and appliance recycling events were discussed. The dates of the recycling events will be decided at a later date. Dan Zaborowski will contact Wellers Salvage and he will also find out what appliances are acceptable.
